



Conditions of Participation: GAME OF THRONES™: The Touring Exhibition

Participation in the Prize Game requires the consent of the participant to the Conditions of Participation. With the participation in the Prize Game the participant accepts these Conditions of Participation. AWC AG reserves the right to exclude participants from the Prize Game in the event of a breach of these Conditions of Participation.

1. Organiser

The organiser of this Prize Game is AWC AG, Corintostr. 1, 51103 Köln.

2. Eligibility for Participation

Persons who have a place of residence in Germany and are at least 18 years old at the participation are eligible for participation. Employees of AWC AG, GES, and HBO (the "Promotion Entities"), and each of their respective relatives and other persons involved in the design and implementation of this Prize Game are excluded from participation. The participant in the Prize Game is the person who is the owner of the Facebook or Instagram account which is used for the participation in the Prize Game. Participation is free of charge and independent from the purchase of goods or services. With the participation in the Prize Game the user accepts these Conditions of Participation.

3. Participation

Participation is possible via Facebook / Instagram account. The prerequisite to participation is the activity specified in the Facebook / Instagram post.

4. Prize

The prize consists in each case of two tickets for GAME OF THRONES™: The Touring Exhibition in Oberhausen for the Cosplay Fan Event on 3 February, 2019. The tickets are drawn for a time slot between 2 pm and 4:30pm and cannot be redeemed on any other day or during any other time slot.

In the event of non-availability the organiser reserves the right to draw the prizes for other participants. The period for the campaign is limited from 25. – 30.01.2019. Participation ends on 30.01.19.

The deadline for participation is 30 January 2019, 11.59 pm.

5. Drawing of the Prizes and Notification

The winner of the Prize Game will be determined by a random draw from all participants by AWC AG. Only the prize described in more detail in the Prize Game is awarded. A cash payment of the real value or an exchange of the prize is not possible. The prize cannot be transferred. The potential winner of the prize will be informed as soon as possible by message via Facebook / Instagram. Upon receipt of the notification the potential winner must confirm immediately but no later than by 31 January 2019 after the notification to AWC AG and submit the personal data required by AWC AG. Otherwise AWC AG is entitled to determine a new potential winner.

6. Premature Ending

AWC AG has, however, the right to end or interrupt the Prize Game at any time if dysfunctions,

interferences, falsifications, viruses or similar serious damage occurs and fundamentally impairs the administration, security, fairness, integrity or procedures of the Prize Game. No claims may be derived from a premature ending.

7. Data Privacy

AWC AG is entitled with a view to the execution of the contract to store and process the personal data obtained within the scope of the Prize Game from the participants in accordance with the provisions of the Federal Data Protection Act to the extent necessary for the implementation of the Prize Game. **The participants are entitled to access or correction in accordance with the statutory provisions and may revoke their consent given online with a view to the processing of their data at any time for the future by email to info@awc-ag.de.** Consequently, the participants agree that their data submitted in respect of the Prize Game are publicly disseminated and / or shared (on Musical.ly, Facebook, Instagram, YouTube etc) by the organisers and third parties (eg partners, online editorial boards, etc). The participants expressly agree that the organiser records the participants audio-visually or has them recorded (eg pictures, videos, films, sound and / or other recording systems). The participants agree to any utilisation of possible recordings (eg picture, sound, video) by the organiser for information and advertising purposes. The decision is final. **Any obligation to pay damages of the Promotion Entities and their respective bodies, employees and vicarious agents under or in connection with the Prize Game for any legal reason whatsoever is restricted – as far as legally admissible – to instances of wrongful intent or gross negligence.** AWC AG reserves the right to amend these Conditions of Participation on good and sufficient grounds. Should individual provisions of the Conditions of Participation be or become invalid, the validity of the remaining Conditions of Participation remains unaffected. The Conditions of Participation as well as the participation itself are governed by the law of the Federal Republic of Germany. **The place of jurisdiction is Cologne.**
